- A minimum cancellation fee of **25%** or **\$35.00** (whichever is greater) will be retained when a permit is cancelled. No fee is returned when an inspection has been carried out.

**If construction has started prior to the approval of the Development Application and Safety Code Permit Application, Permit fees will be doubled per Westlock County Policy 12.01**
